Payment to nominee of Dr. Jackson Kutty:

By the time treasurer had arrived and president enquired about the payment of Dr. Jacksonkutty's claim. Then he informed that he could not effect payment for want of signature of President and Secretary in cheques. The treasurer was entrusted to get the signature of the president and secretary immediately after the meeting and to see that payment is effected at the earliest by utilizing the service of Dr. Manoj Johnson, gov. body member from Kollam. Then the treasurer informed that the cheques are with the Auditor. The President informed the members that office bearers will go to the auditor immediately after the meeting and will sign the cheque and the same will be handed over to Dr. Manoj Johnson.

Part payment list

Part payment list was analyzed and decided to transfer the administrative fund to the administrative fund of the society. Welfare fund, if the member makes the full payment according to the existing rate he/she can be admitted. If the applicant is not willing to pay his amount in the welfare part may be refunded.

It was also decided to refund the excess payment made by Dr. Shahina T.V. The president informed that the office bearers shall spend some more time after the meeting to trace the receipt of the part payment members to get the address and to contact them in person.

Digitalization.

Dr. Siby Chacko made a presentation on this with LCD projector. The work was well appreciated by most of the members when the Treasurer Dr. Biju P. Habeeb registered his opinion that VWS data, in his opinion must be hand written in the registers and there is no use of computerizing the data. Then the Secretary informed the members that Dr. K. D. Paul had been requesting the governing body members to collect fresh application from all the members of the society to update the data. Dr. K.D. Paul, in turn informed that the individual ledger could not be completed for want of completed application from those members being enrolled. The gov. body members collect the cash for membership fee and not the application and the gov. body member dictates the name of applicant with incorrect spelling, hence many entries have not been made in many of the past years also. He also informed that among the gov. body members, fresh applications from Pathanamthitta district alone was received and data updated. Secretary informed the treasurer that; this being the case with individual ledger, which as per auditors report has not been updated since 2007, things will become even worse collecting fresh application and writing it down. It is not going to materialize and the issue will continue. By digitalizing if the governing body member of each district could request the members the member can directly incorporate the changes, and update individual data, which will be approved by two of the office bearers the data gets approved and a print out of the same can be taken and registers can be made up to date.
