Meeting Minutes

Date: 12-06-10

VENUE: Veterinarians building, Kalliath Royal Square, Thrissur

Agenda for GB.

The meeting started at 12.25 noon with the President Dr. A. C. Mohandas on chair. After silent prayer and paying homage to the departed soul of Dr. E. P. Varghese discussions on the agenda started. Dr. K. Vijayakumar introduced Mr. Jayaprakash C.B., CEO, BigI for discussion regarding digitalizing VWS documents. Dr. K.N.M. Nair, Dr. A.C. Mohandas, Dr. Jestin and Dr. K. Vijayakumar took active participation in the discussion. He was requested to furnish the details with anticipated expense in starting and maintaining a web site satisfying requirements of the VWS. In the discussion on computerizing the membership details, Dr. K.D. Paul reported that the individual information data need be updated. Dr. V.K.P. Mohankumar opined to engage a staff for 3 or 4 days on payment basis to assist Dr. K.D. Paul in updating the data and to prepare the list of members with lacking details; which shall be collected by the governing body members from the concerned members in their district. The governing body members can resort to collecting fresh details in the application cum nomination form from the VWS members in their district. Dr. K.N.M. Nair, suggested that the IVA can send SMS to all its members to submit fresh details in the application cum nomination form to governing body members in their districts.

IVA state President Dr. Ramesan was present for the GB and Dr. K.D. Paul briefed the condition of the Veterinarians building at the Kalliyath royal Square and convinced the necessity of acquiring a more spacious own space and building. Dr. Ramesan and Dr. Rama Kammath suggested that a sub committee may be formulated from the Gov. Body of the VWS and to have a discussion with the office bearers of the Trissur IVA.

Dr. S. Gopakumar informed that legal heir ship certificate of late Dr. Jackson Kutty was received and had forwarded copy of cheque for the assistance requesting to forward advance receipt. The GB entrusted Dr. Gopakumar to hand over the cheque to the legal heir on receipt of advance receipt and after getting the concurrence from the treasurer.

Dr. K.N.M Nair informed that an amount of Rs.103301/- (Rupees one lakh three thousand three hundred and one rupees only) is payable to Dr. Beena C. Joseph, nominee of Late Dr. E.P. Varghese, and the GB decided to hand over the check immediately after the meeting.

The president requested the treasurer to present the part payment list in the next GB.

The treasurer reminded the GB members that the membership fee of Rs. 5000/- shall be collected in full or it can be collected as two installments of Rs. 2500/- only.
